Market update

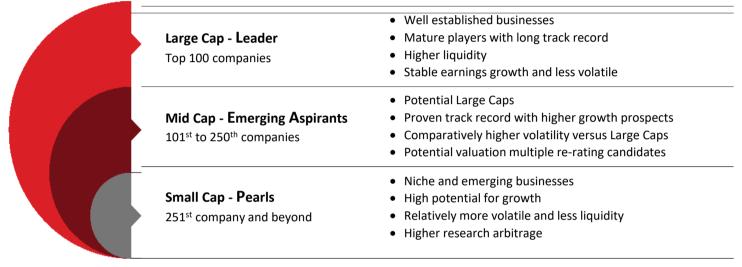




