

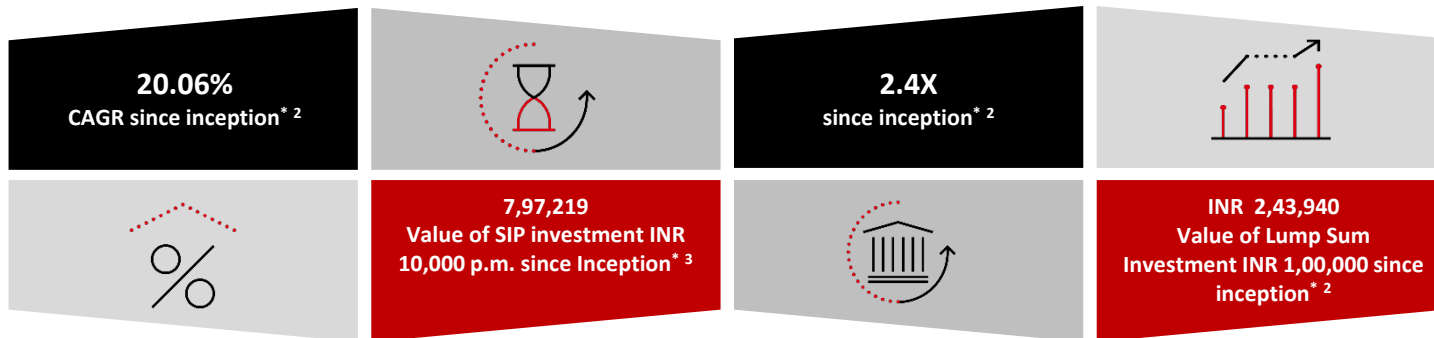

- Aim to create a corpus through generating inflation-adjusted returns to cater to long-term goals
